



# Privacy Policy

This policy outlines how we handle the privacy of information supplied by you on our website [www.Constructionaptitude.co.uk](http://www.Constructionaptitude.co.uk). The website is owned by Construction Aptitude Limited, referred to as "Construction Aptitude" and registered in England and Wales under company number 11123721. This Privacy Policy forms part of our terms and conditions and is designed to help you understand how we collect, use and safeguard information we receive from website visitors and customers.

## Data protection

Under Data Protection legislation all individuals have the right to access their personal data and when processing data on your behalf we will comply with the provisions of the Data Protection Act 1998 and the Privacy and Electronic Communications Regulations 2000. From 25 May 2018 we will also act in accordance with the General Data Protection Regulations (GDPR) and Data Protection Bill 2018.

We keep all data in our secured systems. Personal Information will only be given to a third party where permission has been given or as required by the law as specified in the Regulations.

## Legal basis

By placing an order with us you are entering into a contract or taking steps to enter into a contract and therefore agreeing to the transfer of your details that will enable us to facilitate the completion of that contact. On completion of that contract we may contact you from time-to-time for marketing purposes with regards to products you have a legitimate interest in purchasing.

Customer reviews will only be used on the website or in other media with the express permission of the customer.

## Information we collect

We collect "non personal" and "personal information". Non personal information includes information that cannot be used to personally identify you. Personal information includes the details you use when contacting us via the website such as your name and email address. This is required for initial communications.

We will only send you emails about our products and services (i.e. direct marketing) with your express consent. You have the option not to give consent and to withdraw consent at any time. You may withdraw your consent for us to contact you by contacting us at "Construction Aptitude".

We may disclose your personal information if we are required to do so by law, in connection with any legal proceedings, and in order to establish, exercise or defend any action taken against us.
